



## ANNUAL DIOCESAN TUITION FEES – 2017

Annual Diocesan Tuition Fees can be paid upfront at the start of the year or as three equal payments in Terms 1, 2 and 3. The fee is only charged for the first three (3) children currently enrolled in the Diocese (in other words, there is no additional Diocesan Tuition Fee for the fourth or subsequent child/ren attending a systemic school in the Diocese or other participating Catholic schools – see ‘Sibling Discounts’ below. To work out how much the tuition fee is for each child, see the table below.

The 2017 Annual and Term Diocesan Tuition Fees are as follows:

## ANNUAL DIOCESAN BUILDING LEVY – 2017

In addition to the Annual Diocesan Tuition Fees, families with one or more children in a Parramatta Diocesan school or at St Dominic’s College, Kingswood are required to pay the annual Diocese of Parramatta Diocesan Building Levy. ***The levy for 2017 is \$756.00 per family, payable in three equal instalments of \$252.00 payable in terms one, two and three.***

## ENROLMENT AND OTHER SCHOOL BASED FEES – 2017

A **General Contribution Fee** is charged per student. This replaces the previous Resource and Administration Fees and includes excursions, incursions etc. This fee **EXCLUDES** the trips to Vision Valley and Canberra by Years 5 and 6 which will be invoiced separately. The current General Contribution Fee is \$405.00 (\$135.00 Term 1, 2 and 3) for the first child and \$273.00 (\$91.00 Term 1, 2 and 3) for second and subsequent child/ren.

A fee of \$100.00 is payable on **Acceptance of Enrolment**. This amount will be deducted from Term 1 fees.

## ANNUAL DIOCESAN EDUCATION FEE TEMPORARY RESIDENTS – 2017

The Diocesan Education Fee Temporary Residents for 2017 is **\$1,869.00 per student, payable in three equal instalments of \$623.00 in terms one, two and three.** The fee applies to new students on the following Visa numbers: **173, 401, 402, 411, 415, 416, 417, 418, 419, 420, 421, 422, 423, 426, 427, 428, 442, 456, 457, 459, 462, 476, 485, 497, 580, 600, 601, 651, 675, 676, 679, 685, 884, 944, 956, 976 and 977** including where any of these are the preceding visas for families on bridging visas 010 to 090. Families

charged this fee in 2013 will continue to be charged on a per family basis to the eldest student whilst the family has continuous current students.
